OR be approved by the AKC to judge Havanese
OR have Life experience of 15 years in dogs in general, 5 years in Havanese. If first breed is Havanese, 8 years in the breed.
2. Must have attended at least one HCA Judges Education presentation
3. Must sign the agreement below to uphold the standard when talking to judges
4. Must agree to take an open book written or verbal test on canine structure and the Havanese standard and pass with a score of >= 90%
